

Expression of Interest (E.O.I.) for empanelment of Agencies/

1. Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGA) is being implemented throughout India, in which there is a provision of irrigation wells for specified categories of beneficiaries.

2. In order to facilitate this programme and for effective implementation, the Divisional Commissioner, Nagpur desires to empanel reputed NGOs / professional agencies for the following purposes.

(a) Identification of beneficiaries as per MGNREGA norms, assisting them in following the prescribed procedures, capacity building of beneficiaries and handholding support for execution of works.


(b) To identify suitable schemes for convergence of schemes like providing motor pumps, micro irrigation etc. and to facilitate the process.

3. The agencies desirous to participate in this programme are requested to submit EOI to the undersigned on or before 13/01/2012 upto 15.00 hrs.

4. The District Collectors or the Zilla Parishads of Nagpur division will call for financial bids, based on which the agencies will be entrusted with the work.

The empanelment will be based on assessment of the professional competence of the agencies whereas their deployment will be based on the financial bidding at the district level.

Terms and Conditions

1. Agency/ NGOs should have experience of minimum 3 years in PRA, micro planning process, Training & capacity building, planning and implementation of construction activities. The NGO should be a registered legal entity of at least 5 years standing.

2. Agency/ NGOs applying should have a team of qualified professionals having sufficient knowledge of wells construction.

3. The financial bidding will be tentatively linked to the cost of wells to be taken up under the aegis of the agency. The criteria and instalments for payment will be defined by the District Collectors.

4. Interested agencies/ NGOs shall submit their proposals in prescribed proforma attached herewith.

5. The agency/NGO will be required to give presentation of their proposal on specified date.
